## **RESOLUTION NO. 2090-2025**

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH JANUARY BUILDERS FOR THE PROPOSED BOX CULVERT AND CONCRETE ROAD PAVEMENT IN BARANGAY NORTH POBLACION, CITY OF NAGA, CEBU IN THE AMOUNT OF NINE MILLION ONE HUNDRED EIGHTY-SEVEN THOUSAND FOUR HUNDRED EIGHTY PESOS AND 28/100 (₱9,187,480.28)

WHEREAS, the City Government of Naga, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website an Invitation to Bid to PhilGEPS-registered contractors and bidders for the project: "Supply of labor, materials and tools for the proposed box culvert and concrete road pavement in Barangay North Poblacion, City of Naga, Cebu";

WHEREAS, January Builders, represented by its authorized representative Ms. Julien A. Sedentario, has submitted its bid price in the amount of ₱9,187,480.28 and was found to be the lowest calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and January Builders, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with January Builders for the proposed box culvert and concrete road pavement in Barangay North Poblacion, City of Naga, Cebu in the amount of Nine Million One Hundred Eighty-Seven Thousand Four Hundred Eighty Pesos and 28/100 (₱9,187,480.28).
