RESOLUTION NO. 2091-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH ICAN CONSTRUCTION SERVICES FOR THE REHABILITATION OF LOOP STRUCTURE DECKING AT PASILONG SA NAGA, BARANGAY EAST POBLACION, CITY OF NAGA, CEBU IN THE AMOUNT OF FIVE MILLION ONE HUNDRED NINETY-SIX THOUSAND NINE HUNDRED SIXTY-EIGHT PESOS AND 44/100 (₱5,196,968.44)

WHEREAS, the City Government of Naga, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) an Invitation to Bid to PhilGEPS-registered contractors and bidders for the project: "Supply of labor, materials and equipment for the rehabilitation of loop structure decking at Pasilong sa Naga, Barangay East Poblacion, City of Naga, Cebu";

WHEREAS, ICAN Construction Services, represented by its authorized representative Ms. Sraelyn Joy E. Inocencio, has submitted its bid price in the amount of ₱5,196,968.44 and was found to be the lowest calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and ICAN Construction Services, so as to ensure proper implementation of the project in accordance with the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with ICAN Construction Services for the rehabilitation of loop structure decking at Pasilong sa Naga, Barangay East Poblacion, City of Naga, Cebu in the amount of Five Million One Hundred Ninety-Six Thousand Nine Hundred Sixty-Eight Pesos and 44/100 (₱5,196,968.44).
