## **RESOLUTION NO. 2092-2025**

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF NAGA, CEBU, A CONTRACT OF AGREEMENT WITH FIRST GRANDEUR BUILDERS FOR THE PROPOSED CONSTRUCTION OF A MULTI-PURPOSE COVERED COURT/EVACUATION CENTER IN BARANGAY NAALAD, CITY OF NAGA, CEBU IN THE AMOUNT OF ONE MILLION FIVE HUNDRED EIGHTY-FIVE THOUSAND EIGHT HUNDRED EIGHTY PESOS AND 18/100 (₱1,585,880.18)

WHEREAS, the City Government of Naga, through the Bids and Awards Committee (BAC), posted on the Philippine Government Electronic Procurement System (PhilGEPS) official website the Request for Quotation for the project: "Supply of labor, materials and equipment for the proposed construction of a multi-purpose covered court/evacuation center in Barangay Naalad, City of Naga, Cebu";

WHEREAS, First Grandeur Builders, represented by its authorized representative Mr. Gavino T. Umali, has submitted its bid price in the amount of ₱1,585,880.18 and was found to be the lowest calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government of Naga, Cebu and January Builders, so as to ensure proper implementation of the project in accordance with the approved program of works.

**NOW THEREFORE**, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government of Naga, Cebu, a Contract of Agreement with First Grandeur Builders for the proposed construction of a multi-purpose covered court/evacuation center in Barangay Naalad, City of Naga, Cebu in the amount of One Million Five Hundred Eighty-Five Thousand Eight Hundred Eighty Pesos and 18/100 (₱1,585,880.18).
