RESOLUTION NO. 2093-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH BT CONSTRUCTION AND GENERAL SERVICES FOR THE PROPOSED ONE HUNDRED FOOT (150-FT) DEEP WELL CONSTRUCTION WITH HAND PUMP AT SITIO KAPIHAN, BARANGAY COGON, CITY OF NAGA, CEBU IN THE AMOUNT OF TWO HUNDRED FIFTY-FIVE THOUSAND FIVE HUNDRED NINETY-SEVEN PESOS AND 91/100 (P255,597.91)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on Philippine Government Electronic Procurement System (PhilGEPS) official website the request for quotation for the project: *"Supply of labor, materials and equipment for the proposed construction of a one hundred foot (150-ft) deep well with hand pump at Sitio Kapihan, Barangay Cogon, City of Naga, Cebu";*

WHEREAS, in the Abstract of Quotation dated May 13, 2025, BT Construction and General Services submitted the lowest calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government and BT Construction and General Services, so as to ensure proper implementation of the project in accordance with the approved program of works.


NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it




