RESOLUTION NO. 2094-2025

AUTHORIZING THE HONORABLE CITY MAYOR VALDEMAR M. CHIONG TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OF AGREEMENT WITH BT CONSTRUCTION AND GENERAL SERVICES FOR THE IMPROVEMENT OF BARANGAY HALL IN CENTRAL POBLACION, CITY OF NAGA, CEBU AMOUNTING TO NINE HUNDRED SEVENTY-FOUR THOUSAND TWO HUNDRED FORTY-EIGHT PESOS AND 10/100 (₱974,248.10)

WHEREAS, the City Government, through the Bids and Awards Committee (BAC), posted on Philippine Government Electronic Procurement System (PhilGEPS) official website the request for quotation for the project: "Supply of labor, materials and equipment for the proposed improvement of Barangay Hall in Central Poblacion, City of Naga, Cebu";

WHEREAS, in the Abstract of Quotation dated May 13, 2025, BT Construction and General Services submitted the lowest calculated and responsive price quotation for this project;

WHEREAS, there is a need to execute a contract by and between the City Government and BT Construction and General Services, so as to ensure proper implementation of the project as contained in the approved program of works.

NOW THEREFORE, on motion of Hon. Ray A. Manabat, seconded by Hon. Dominador A. Libor, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Valdemar M. Chiong to sign, for and in behalf of the City Government, a Contract of Agreement with BT Construction and General Services for the proposed improvement of Barangay Hall in Central Poblacion, City of Naga, Cebu in the amount of Nine Hundred Seventy-Four Thousand Two Hundred Forty-Eight Pesos and 10/100 (₱974,248.10).
