RESOLUTION NO. 2096-2025

APPROVING THE ADDITIONAL BATCH FOR SPECIAL PROGRAM FOR EMPLOYMENT OF STUDENTS 2025 FOR THE MONTHS OF JUNE AND JULY 2025 CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF ONE HUNDRED SEVENTY-NINE THOUSAND THREE HUNDRED THIRTY-FOUR PESOS (₱179,334.00)

WHEREAS, the City Government of Naga, Cebu, through the City Public Employment Service Office (PESO), hires and employs students pursuant to Republic Act (R.A.) No. 7323, otherwise known as the "Special Program for Employment of Students" (SPES), as amended by R.A. No. 9547 and R.A. No. 109171;

WHEREAS, SPES is a youth employment - bridging program aimed at providing temporary employment to poor but deserving students and out of school youth during summer or Christmas vacation so as to augment their family's income as well as help them finish their studies:

WHEREAS, the City Government and the Department of Labor and Employment (DOLE) 7 will implement the program for additional batch of SPES for the months of June and July 2025 with an allocation of twenty-seven (27) beneficiaries in which the City Government, being the employer, shall pay the student employee equivalent to sixty percent (60%) of the applicable minimum wage in the area while the remaining forty percent (40%) shall be shouldered by the DOLE:

WHEREAS, the City prioritizes those students who have already availed of the program and were classified as "SPES babies" so as to continually help them in their pursuit of finishing their education.

NOW THEREFORE, on motion of Hon. Letecia F. Abangan, seconded by Hon. Justino L. Dakay for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to approve the additional batch for the SPES 2025 for the months of June and July 2025 chargeable against lump sum appropriation specifically General Fund 2025 - Other MOOE: SPES Program (Public Employment Services Office) in the amount of One Hundred Seventy-Nine Thousand Three Hundred Thirty-Four Pesos (₱179,334.00)
