WAIVING THE FEES FOR MARRIAGE LICENSE AND OTHER LOCAL CIVIL REGISTRY (LCR) REQUIREMENTS FOR THE CITY-ASSISTED FREE MASS WEDDING FOR INDIGENT COUPLES DURING THE 18TH CHARTER DAY ANNIVERSARY CELEBRATION OF THE CITY OF NAGA, CEBU

WHEREAS, Article II, Section 12 of the 1987 Philippine Constitution provides that "The State recognizes the sanctity of family life and shall protect and strengthen the family as a basic autonomous social institution;

WHEREAS, the City Government of Naga, Cebu is holding the yearly free mass wedding for indigent couples, who have been living as husband and wife without the benefit of marriage during the City's 18th Charter Day Anniversary Celebration on September 05, 2025;

WHEREAS, the Office of the City Mayor recommended to this Sanggunian that fees for marriage license and other LCR requirements be waived such as follows: application for marriage license, birth certificate, death certificate, marriage counseling and family planning, marriage solemnization and Batch Request Entry Query System (BREQS) service fee for birth, death and Certificate of No Marriage Record (CENOMAR).

NOW THEREFORE, on motion of Hon. Charmaine R. Navarro, seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby RESOLVED, to waive the fees for marriage license and other LCR requirements for the city-assisted free mass wedding for indigent couples during the 18th Charter Day Anniversary Celebration of the City of Naga, Cebu.
