RESOLUTION NO. 2099-2025

APPROVING THE AMOUNT OF TWO MILLION SEVEN HUNDRED THOUSAND PESOS (P2,700,000.00) CHARGEABLE AGAINST LUMP SUM APPROPRIATION FOR THE IMPLEMENTATION OF THE CITY OF NAGA TUTORING PROGRAM

WHEREAS, the City Government, in partnership with THECHALKBOARD INC., has implemented a 25-day tutoring program under the Academic Remediation, Acceleration, and Livelihood (ARAL) Program which provides free tutorials to young learners who need assistance in reading, mathematics and sciences, whether through face-to-face, online or blended modalities;

WHEREAS, a total of four hundred fifty (450) learners from elementary schools in Barangays Alpaco, Tagjaguimit, Mayana, Cabungahan, Jaguimit, Patag, Tuyan, Inayagan, Cogon and Naga Central School have benefited the program covering the months of January to March 2025;

WHEREAS, the City Government is committed to continuing this comprehensive tutoring initiative program which already achieved an impressive average learning gain of seventy-seven percent (77%) among participating learners;

WHEREAS, the August Body, in a session duly assembled, deemed it justifiable to pursue the program whose primary aim is to further bridge the literacy gaps that may lead to the total personal development and growth of the city's youth and children.

NOW THEREFORE, on motion of Hon. Carmelino N. Cruz, Jr., seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to approve the amount of Two Million Seven Hundred Thousand Pesos (P2,700,000.00) chargeable against lump sum appropriation for the implementation of the City of Naga Tutoring Program.
