## **RESOLUTION NO. 2101-2025**

APPROVING THE PROCUREMENT OF TEN (10) PIECES TARPAULIN (SIZE 4X8) FOR THE 2025 FREE MASS WEDDING FOR INDIGENT COUPLES CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF FOUR THOUSAND EIGHT HUNDRED PESOS (₱4,800.00)

WHEREAS, the annual free mass wedding is one of the activities highlighting the Charter Day Celebration of this local government unit with the purpose of legalizing the union of indigent couples who have been living as husband and wife without formal matrimonial rites;

WHEREAS, the Office of the City Civil Registrar has requested this Sanggunian for the passage of a resolution approving the procurement of at least ten (10) pieces tarpaulin (size 4x8) to be used during this city-assisted free mass wedding;

WHEREAS, this Body deemed the request justifiable to ensure the successful holding of this year's free mass wedding.
