RESOLUTION NO. 2102-2025

AUTHORIZING SANGGUNIANG KABATAAN (SK) FEDERATION PRESIDENT FAITH
JAMES B. SERVANO AND SK FEDERATION TREASURER EREL TRINITY ALFECHE TO
APPLY FOR A TAXPAYER IDENTIFICATION NUMBER (TIN) AT THE BUREAU OF
INTERNAL REVENUE (BIR) FOR THE PURPOSE OF OPENING AN OFFICIAL BANK
ACCOUNT FOR THE CITY OF NAGA SK FEDERATION

WHEREAS, subjected to deliberation is the request of the City of Naga SK Federation for the passage of a resolution authorizing SK Federation President Faith James B. Servano and SK Federation Treasurer Erel Trinity Alfeche to apply for a TIN at the BIR;

WHEREAS, the TIN is a fundamental requirement for opening a bank account for the City of Naga SK Federation pursuant to the legal mandates, to wit:

- Republic Act No. 10742 or the SK Reform Act of 2015, specifically Section 20, which mandates proper financial handling and maintenance of bank accounts for SK funds;
- Commission on Audit Circular No. 2017-001, which requires all SK funds to be deposited and disbursed through official bank accounts; and
- Department of Interior and Local Government Memorandum Circular No. 2018-46, which directs all SK Federations to open and maintain bank accounts to ensure compliance with government accounting and auditing procedures.

WHEREAS, the August Body, in a session duly assembled, deemed it necessary to approve the request to ensure transparency, accountability and proper handling of funds of the City of Naga SK Federation.

NOW THEREFORE, on motion of Hon. Faith James B. Servano, seconded by Hon. Letecia F. Abangan, for the approval of the resolution, be it

RESOLVED, as it is hereby **RESOLVED**, to authorize SK Federation President Faith James B. Servano and SK Federation Treasurer Erel Trinity Alfeche to apply for a TIN at the BIR for the purpose of opening an official bank account for the City of Naga SK Federation.
