RESOLUTION NO. 2103-2025

APPROVING THE SUPPLY AND DELIVERY OF MEALS FOR BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) PROBATIONERS AND PAROLEES PARTICIPATING IN THE CITY OF NAGA ENVIRONMENT AND NATURAL RESOURCES (CENRO) TREE PLANTING ACTIVITY CHARGEABLE AGAINST LUMP SUM APPROPRIATION IN THE AMOUNT OF TWENTY-EIGHT THOUSAND PESOS (₱28,000.00)

WHEREAS, the Sangguniang Panlungsod passed Ordinance No. 2014-008, entitled: "An Ordinance declaring the third Saturday of June of every year as Arbor Day in the City of Naga, Cebu;"

WHEREAS, the City Government, through the CENRO, will hold a tree planting activity on July 21, 2025 pursuant to the above-mentioned City Ordinance;

WHEREAS, the Office of the City Mayor requested this Sanggunian for approval of the supply and delivery of meals for BJMP probationers and parolees who will participate in this annual tree planting activity;

WHEREAS, this August Body, in a session duly assembled, found it justifiable to approve the request for funding allocation amounting to ₱28,000.00 so as to ensure the successful holding of the aforementioned activity.
