**RESOLUTION NO. 2104-2025**

**AUTHORIZING AND DESIGNATING THE HONORABLE CITY VICE MAYOR VIRGILIO M. CHIONG AS ALTERNATE SIGNATORY OF ALL CITY GOVERNMENT'S BANK ACCOUNTS TOGETHER WITH CITY TREASURER TRINA L. LITORJA DURING THE PERIOD OF LEAVE OF ABSENCE OF THE LOCAL CHIEF EXECUTIVE (LCE) FROM JUNE 20, 2025 TO JULY 03, 2025**

**WHEREAS**, section 311 of R.A. 7160, otherwise known as the Local Government Code of 1991 provides that *"Local treasurers shall maintain depository accounts in the name of their respective local government units with banks, preferably government-owned, located in or nearest to their respective areas of jurisdiction. Earnings of each depository account shall accrue exclusively thereto;"*

**WHEREAS**, the Honorable City Mayor Valdemar M. Chiong is taking a leave of absence effective June 20, 2025 until July 03, 2025, thus, mandating the city vice mayor to temporarily assume the city's top elective post as provided for under Section 46 of RA 7160, and to exercise the powers and perform the duties and functions of the same, subject to the limitations enumerated therein;

**WHEREAS**, this Sanggunian deems it appropriate to authorize and designate the Honorable City Vice Mayor Virgilio M. Chiong as alternate signatory to ensure uninterrupted delivery of public service and continuous processing of financial and administrative transactions such as but not limited to payment of salaries and wages, remittances, loan payments, fuel and Assistance in Crisis Situation (AICS) on emergency cases during the above-cited period of leave of absence of the LCE.






